HOW TO GET THERE FROM:

Interstate 25: north bound, take exit 10B, **south bound**, take exit 10D. Both exit to Happy Jack Rd. Turn west, toward Laramie, drive 17 miles. Just past mile marker 17, turn left into arena driveway.

Interstate 80: west bound, exit to I-25 north and follow I-25 directions; **east bound**, take Happy Jack Road Exit about five miles east of Laramie, cross bridge, turn left. Drive about 21 miles and turn right into second entrance after mile marker 18, 50 yards past the lit entrance.
